### GENERAL INFORMATION

HYE-GREEN 21-21-21 is a water-soluble foliar fertilizer containing various micronutrients important to healthy plant development. HYE-GREEN 21-21-21 should be mixed with water prior to application and may be used in conjunction with pesticide sprays except lime sulfur and highly alkaline spray materials. The rates given under DIRECTIONS FOR USE should be adjusted according to the crop stage of development, the number of applications intended, and soil & weather conditions.

If only a single application is intended or when soil and weather conditions are unfavorable for crop growth, higher rates are recommended. Lower rates are recommended when leaf area is small, new growth exists or on new plantings. For best results, applications should begin as soon as the leaves are large enough to absorb and utilize the nutrients and should continue at 10-14 day intervals during the primary growth period.

This product can be used in crop protection sprays with a minimum volume of 20 gallons of spray per acre by ground and 5 gallons of spray per acre by air. However, the concentration of HYE-GREEN 21-21-21 solution should not exceed 20 pounds in 50 gallons of water. When spraying blossoms, use lower rates and/or higher dilution rate. Do not store under excessive hot or cold temperatures for long periods. May be corrosive to mild steel and brass.

### DIRECTIONS FOR USE

**ROW, FIELD AND VEGETABLE CROPS** (such as Alfalfa, Beans, Broccoli, Carrots, Cauliflower, Corn, Cotton, Cucumbers, Eggplant, Onions, Peas, Peppers, Sorghum, Sugarbeets, Tomatoes and Wheat). Do not apply to Leafy Vegetables. Apply 2-20 lbs. per acre in sufficient water to cover foliage when plants are 3 to 4 weeks old and repeat as needed.

**CITRUS & AVOCADOS:** Apply at 5-20 pounds per acre in sufficient water to cover. Make applications at pre-bloom stage, when fruit is sizing, and after harvest. FOR NON-BEARING TREES, apply at 2-5 lbs. per acre in sufficient water to cover foliage.

**NUTS:** Apply at 5-20 pounds per acre in sufficient water to cover. Apply to mature trees. FOR NON-BEARING TREES, apply at 2-5 lbs. per acre in sufficient water to cover foliage.

**GRAPES & BERRIES:** Apply Hye-Green 21-21-21 at 2-5 pounds per acre in 50-100 gallons of water. FOR NON-BEARING VINES, apply at 1-3 lbs. per acre in sufficient water to cover foliage.

**STONE & POME FRUIT:** Apply Hye-Green 21-21-21 at 5-10 pounds per acre in sufficient water to cover. Make applications at pre-bloom stage, when fruit is sizing, and after harvest. FOR NON-BEARING TREES, 2-5 lbs. per acre in sufficient water to cover foliage.

**WARNING:** Application of fertilizers containing molybdenum may result in forage crops that contain levels of molybdenum that are toxic to ruminant animals. The proper use of soil and/or petiole test recommendations will minimize the risk of over-application of molybdenum.
