GENERAL INFORMATION

HYE-GREEN MICRO-MIX is specifically designed for use in Citrus crops as a water-soluble foliar fertilizer containing zinc, sulfur, manganese and magnesium.

The rates given under DIRECTIONS FOR USE should be adjusted according to the crop stage of development, the number of applications intended, and soil and weather conditions. Higher rates are recommended when conditions include applying sprays in excess of 250 gallons of water per acre on mature, hardened off leaves. Lower rates are recommended when conditions include small-leaf area, new growth, bloom or the previously mentioned combinations in sprays of less than 100 gallons of water per acre. For best results, applications should begin as soon as the leaves are large enough to absorb and utilize the nutrients and should continue at 14-20 day intervals during the primary growth period.

This product can be used in crop protection sprays with a minimum volume of 20 gallons of spray per acre by ground and 5 gallons of spray per acre by air. However, the concentration of HYE-GREEN MICRO-MIX should not exceed 10 pounds in 100 gallons of water. Do not store under excessive hot or cold temperatures for long periods. May be corrosive to mild steel and brass.

DIRECTIONS FOR USE

With all use: in water volumes under 250 gallons per acre, always test pH levels before application; especially when mixing with other products or nutrients. pH levels must be 5.7 or greater.

CITRUS: Apply HYE-GREEN MICRO-MIX in water at sufficient levels to cover foliage. When spraying blossoms or new/tender growth in less than 100 gallons of water per acre, use 5 lbs or less of this product per spray acre. In 250 gallons, use 5 to 12.5 lbs of this product per spray acre.

HYE-GREEN MICRO-MIX can be used in combination with 4 to 12.5 pounds per acre of Hye-Green 21-21-21 or 2-18-40 to supply N-P-K. Make applications at pre-bloom stage, when fruit is sizing, and to trees after harvest. **NON-BEARING TREES:** apply at 1-2 lbs. HYE-GREEN MICRO-MIX per acre in water sufficient to cover foliage. Consult your GAR advisor for advice prior to use.
