8-8-8 is a water-soluble low pH soil applied liquid fertilizer important to healthy plant development.

DIRECTIONS FOR USE

8-8-8 is a soil amendment. 8-8-8 delivers a valuable source of Nitrogen, Phosphorous and Potassium for treating nutrient disorders in crops. 8-8-8 can be applied to increase nutrient availability to targeted crops. Application of 8-8-8 should be made based on soil, water and plant tissue analysis.

Soil Rate

Apply 8-8-8 as a single or multiple applications at the rate of 5 to 25 gallons per acre.

Fertigation Application

When injecting into a irrigation system, do not allow treated water to drop below a pH of 6.0. Avoid mixing this product with high bicarbonate water and calcium products such as CAN17 and CN9 or with thiosulfate products such as ATS, MgTS, KTS and CaTS. Always flush the irrigation system with clean untreated irrigation water.
