Hye-Green 2-6-10 is a water-soluble low pH soil applied liquid fertilizer important to healthy plant development.

### DIRECTIONS FOR USE

Hye-Green 2-6-10 is a soil amendment. Hye-Green 2-6-10 delivers a valuable source of Nitrogen, Phosphorous and Potassium for treating nutrient disorders in crops. Hye-Green 2-6-10 can be applied to increase nutrient availability to targeted crops and to help leach out harmful salts, in turn improving water infiltration. Application of Hye-Green 2-6-10 should be made based on soil, water and plant tissue analysis.

### Soil Applied Rate

Apply Hye-Green 2-6-10 as a single or multiple applications at the rate of 5 to 25 gallons per acre.

### Fertigation Application

When injecting into a irrigation system, do not allow treated water to drop below 6.0. Avoid mixing this product with high bicarbonate water and calcium products such as CAN17 or CN9 and with thiosulfate products such as ATS, MgTS, KTS and CATS. Always flush the irrigation system with clean untreated irrigation water.

### Field and Vegetable Crops

(Including tomatoes, melons, peppers, onions and corn) Apply Hye-Green 2-6-10 at 2-5 gallons per acre as a pop up fertilizer at time of seed planting in moist soil. **Dry Conditions at Planting:** The potential for damage from seed placed fertilizer increases as the soil dries. Soils with a sandy texture dry more rapidly than others. Special caution and lower rates should be used in dry or sandy soils.
